Service description: Trinity VDP operates three youth activity clubs in three locations – Andrew Court Kids Club, Pearse Street Kids Club and the Trinity Youth Club. These clubs offer registered children and young people the opportunity to engage in outings and trips to local venues of interest and also from time to time to undertake indoor activities in Trinity College and SVP’s Ozanam House Resource Centre

- Procedures for appointing a relevant person for the purposes of the Statement.
